

CASA Volunteer Kerri was first assigned to her case in December of 2015. Her case involved a 14-year-old named JoJo who had recently been placed in foster care as a result of physical abuse at the hands of her mother and her mother's boyfriend. At first, JoJo was slow to trust CASA Kerri. For several months CASA Kerri would leave her weekly visits with JoJo not feeling like she was having any real impact and being unsure how JoJo felt about her. Nonetheless, CASA Kerri continued to arrive for her weekly visits with JoJo and slowly but surely the two began to bond. Somedays JoJo would not feel up for talking so they would just go on a quiet walk around JoJo's foster home neighborhood. Other days, JoJo would be frustrated by something that was happening on her case or at school and they would vent and cry as CASA Kerri listened and supported them.

CASA Kerri was and is a true constant for JoJo as their case went on for over five years. There were times when JoJo was so exhausted by being in foster care that they refused to talk to almost anyone but even in these dark moments, they would always answer CASA Kerri's calls. CASA Kerri was the first-person JoJo wanted to talk to about anything and everything, including when they opened up to CASA Kerri about how they are nonbinary.

At age 18, JoJo emancipated from foster care. With CASA Kerri's encouragement and support, JoJo enrolled in college. Even though JoJo's case is closed, CASA Kerri remains as present as ever in JoJo's life and we have no doubt they have formed a lifelong connection.



Advocates for Children CASA was founded over 37 years ago as a response to child abuse and to help provide children who had been abused and neglected a voice in the courtroom. We've learned a lot about our community in those 37 years and have recognized the need for wraparound services focused on prevention.

OUR PROGRAMS

SAFE BABIES COURT 2

80% OF BRAIN DEVELOPMENT OCCURS WITHIN THE FIRST 1,000 DAYS OF A BABIES LIFE

Safe Babies Court is a program that focuses on children between the ages of 0-3. This program is a collaborative effort with our community partners and

Our communities saw chronic absenteeism, with students of color disproportionally represented, more than double during the 2020-21 school year, rising to 23% from 10% the year prior.



55.4% of students in foster care moved into or out of their district in a school year.

DEPENDENCY AND NEGLECT

Court Appointed Special Advocate (CASA) Volunteers provide the Court and other responsible persons with independent and objective information regarding the safety, permanency and wellbeing of the child. CASAs learn of the opportunities for advocacy by spending time with their child. Children and youth involved in our Dependency & Neglect program are appointed through the court system and not referrals.



LESS THAN ONE IN FOUR STUDENTS IN FOSTER CARE GRADUATE HIGH SCHOOL IN FOUR YEARS

Our Truancy program assigns CASA volunteers to cases that are open due to underlying barriers that are keeping children out of school. The purpose

TUTORING 3 PROGRAM

Our Tutoring program was developed to address the increased need for educational support as our children who are involved in child welfare are moved from placement to placement and school to school.

JUVENILE DELINQUENCY CASAS

ONCE ARRESTED, CHILDREN OF COLOR OR SPECIAL NEEDS ARE LESS LIKELY TO BE CONNECTED TO COMMUNITY-BASED PROGRAMS.

Our Juvenile Delinquency CASA program assigns volunteers to youth with an open case in the juvenile justice system. These volunteers focus on the youth's strengths and actionable goals as they provide ongoing support and advocacy.

LEGACY PROJECT

Our Legacy Project focuses on serving youth between the ages of 13-23 who need support in becoming self-sufficient. These youth are paired with a mentor who works with them on acquiring life skills, goal setting, and resource navigation within the community, so they can become independent adults.

Douglas County Collaborative Management Program [DCCMP] serves Douglas County youth, families, and agencies by providing a collaborative format to have a productive dialogue regarding appropriate, effective, and efficient service delivery and access. 



CHILDREN SERVED WITH A VOLUNTEER BY RACE




