The potential conflict is then brought to the entire Board, discussed, and a vote is taken to determine whether or not to proceed with the business relationship. The discussion and vote are documented in the meeting minutes.

Periodically, salaries are compared with relevant data, including the Colorado Nonprofit Resources' annual compensation survey.
